

Cancellation of the New Captive Jetty Policy - 2019 for "Unlocking value in the existing port infrastructure by allowing existing captive jetty holders to handle third party cargo and opportunity for new players" as declared by the Memorandum No. WKS-102019-G-403-GH-1 dated 11-10-2019.

Preamble :

The Government of Gujarat, had *vide* the Memorandum No. WKS-102019-G-403-GH-1 dated 11-10-2019 accorded approval to the Policy for "Unlocking value in existing port infrastructure by allowing existing captive jetty holders to handle third party cargo and opportunity for new year players" (hereinafter referred to as "New Captive Jetty Policy – 2019").

Subsequently, GMB had initiated actions for inviting opt-in/opt-out options from the captive jetty holders, preparation of SOP, signing the Supplementary Agreements with three captive jetty holders, etc. In this context, Government *vide* letter no. WKS-102019-G-63-GH-1 dated 17-12-2019 directed GMB to keep such Supplementary Agreements signed by GMB with Licensees in abeyance with immediate effect till the Model Supplementary Agreement is examined and approved by Government. Subsequently, as proposed by GMB, the Government had *vide* Memorandum dated 28-06-2021 referred as no. ii above, accorded consent for putting the new Captive Jetty Policy – 2019 issued *vide* the Memorandum no. WKS-102019-G-403-GH-1 dated 11-10-2019 in abeyance and permitted GMB to process the development of Captive Jetty Projects under Pre-New Captive Jetty Policy - 2019 regime. Thereafter, GMB had recommended and sought approval of Government through this department to cancel the New Captive



Jetty Policy-2019 declared *vide* Memorandum dated 11-10-2019 *ab-initio* and also allow GMB to process the development of Captive Jetty Projects and all the relevant actions as per Pre-New Captive Jetty Policy 2019 regime. The proposal was under consideration of Government.

Memorandum :

After careful consideration, Government of Gujarat has consented to cancel the Captive Jetty Policy - 2019 (Unlocking Policy) issued *vide* Memorandum No. WKS-102019-G-403-GH-1 dated 11-10-2019 as recommended by GMB. With this, Pre-Captive Jetty Policy - 2019 regime comes into effect.
