This is with reference to the above notification and the notification no. PT/2020/15/WKS/102016/G-396/GH1 dated 10<sup>th</sup> June 2020 issued by Government of Gujarat amending the condition no. 14 for Scheduled of Port Charges (SoPC) for applicability of escalation in all rates by annual Wholesale Price Index effect from 1<sup>st</sup> May every financial year.

In this regards, considering the Weekly Statistical Supplement Vol. 39 dated 19<sup>th</sup> April 2024 issued by Reserve Bank of India ([https://rbidocs.rbi.org.in/rdocs/Wss/PDFs/1T\\_1904202409A6389799744309965E6213E92F1BB2.PDF](https://rbidocs.rbi.org.in/rdocs/Wss/PDFs/1T_1904202409A6389799744309965E6213E92F1BB2.PDF)), Wholesale Price Index (WPI) is observed at 0.5% year-on-year. Hence, the rates applicable previously for FY 2023-24 is hereby escalated by 0.5% w.e.f. 1<sup>st</sup> May 2024, and the indicative statement showing revised rates are enclosed herewith for ready reference and implementation. The escalation effect will be made applicable to all the charges prescribed in above referred notifications. All other terms and conditions of above referred notifications related to Scheduled of Port Charges (SoPC) will remain same and applicable accordingly.
