#### INLAND VESSELS ACT, 2021.

No.G/PT/2024/21/PTD/MIS/e-file/22/2024/0899/GH-1:- WHEREAS certain draft rules to be issued under sub-section(6) of section 5 of the Inland Vessels Act, 2021 (24 of 2021) were published as required by sub-section (1) of section 107 of the said Act at pages 96-1 to 96-20 in the Gujarat Government Gazette, Extraordinary, Part [IV-A], dated the 25<sup>th</sup> June, 2024, under the Government Notification Ports and Transport Department No. G/PT/2024/7/PTD/MIS/e-file/22/2024/0899/GH-1, inviting objections or suggestions from all persons likely to be affected thereby within a period of thirty days from the date of publication of the said notification in the Official Gazette:

AND WHEREAS, objections or suggestions received in respect of the said draft notification have been considered by the Government;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (6) of section 5 read with section 107 of the Inland Vessels Act, 2021 (24 of 2021), the Government of Gujarat hereby makes the following rules, namely:-

1. Short title and commencement.-

- (1) These rules may be called the Gujarat Inland Vessel (Registration, Survey and Operation of Category 'C' Inland Vessels), Rules, 2024.
- (2) They shall come into force on the date of their publication in the *Official Gazette*.

2. Definitions.-

- (1) In these rules, unless the context otherwise requires -
  - (a) "Act" means the Inland Vessels Act, 2021;
  - (b) "Applicant" means the owner and/or the operator of the pleasure craft applying for Registration / survey or any other requirement as set by the Government from time to time under these Rules;

- (c) "Beach" or "shore" or "bank" means the strip/area of waterfront land that is located along a body of water;
  - (d) "Boat" means and include a pleasure craft in the form of a house boat, motor boat, motor launch, pedal boat, rowing boat, parasailing boat and canoe, but does not include fishing vessels and a ship registered or required to be registered under the Merchant Shipping Act, 1958 (44 of 1958);
  - (e) 'Category 'C' Vessel' means a pleasure craft of less than 10 meters length;
  - (f) "Certification Agency" means the agency, which may be a classification society or such other authority, as may be authorised by the Indian Register of Shipping (IRS) for the purpose of fitness certification of crafts for strength, capacity and technical specifications;
  - (g) "Concerned Authority" means the competent body, organization, or institution that has the powers or jurisdiction to operate, manage, supervise, or have control of a specific area;
  - (h) "Fair season" means the period that may be specified by the Directorate General of Shipping, India;
  - (i) "Government" means the Government of Gujarat;
  - (j) "Mechanically Propelled Boat" means any floating craft/boat propelled with mechanized means such as marina, barge, boat, river/lake cruise/yachting, boating, water skiing, jet skiing, fun rides using power boats and such other activities;
  - (k) "Misconduct" means fraud, misrepresentation, obstructing tourist facilities, or charging extra, not displaying the rent charges, not giving cash memo/receipt, not providing committed facilities/services, providing lower grade equipment or not making available experts/ technical personnel/operating without permission from the registering authority; not following strict safety-related protocols, not providing all safety equipment required for an activity, not maintaining safety-related equipment or protocols or directly or indirectly endangering the lives of any occupants of a Vessel;
  - (l) "Non-mechanically propelled Boat" means any boat/ floating object propelled without any mechanical means of propulsion and may include floating crafts such as, pontoon, floating huts, house boats, zorbing, sailing or rowing, canoeing, yachting, wind surfing, dingy sailing and such other activities;
  - (m) "Nuisance" means any act by the operator or applicant in contravention or violation to the provisions of these Rules or operating the activities without proper approval from the registering authority;
  - (n) "Operator" means a person or entity either owning or operating or proposing to own or operate a Vessel for water sports such as pleasure boating, ferry service, parasailing, jet-ski, kayaking, water skiing/towing, canoeing, rafting, scuba diving and such other or further recreational activities in inland waters, in the State of Gujarat;
  - (o) 'Pleasure craft' means a vessel that is used, or, being a vessel in the course of being constructed, or is intended to be used, wholly or partially for recreational or sporting activities;
  - (p) "Registrar" means the officer appointed by the Government for the purpose of registration of the Category 'C' vessels according to the Inland Vessels Act,2021;
  - (q) "Surveyor" means the officer appointed by the Government for the purpose of survey of the Category 'C' vessels according to the Inland Vessels Act, 2021.
- (2) Words and expressions used and not defined in these rules but defined in the Act shall have the meanings respectively assigned to them in the Act.

### 3. Applicability.-

- (1) These rules relate to registration of boats/equipment for water sports activities and shall be applicable to all pleasure crafts falling under Category 'C' vessels as classified in rule 6 of the Inland Vessels(Survey and Certification)Rules, 2022 published by the Central Government and also to operators engaged in conducting such activities within the State of Gujarat.
- (2) These rules shall govern the process of registration, survey, certification, and operational compliance for all pleasure crafts and boats plying in inland waters within the State of Gujarat.

## 4. Registration and Survey Procedure.-

- (1) Any person or entity desirous of securing a registration for his/its pleasure craft/boat (the "Applicant"), shall apply to the Registrar having respective jurisdiction. The application shall be made in FORM 1 along survey application in FORM 2 with payment of a Registration and Survey Fee as prescribed in SCHEDULE B.
- (2) The Applicant shall be required to furnish the following documents along with the application:
  - (i) Documents evidencing ownership of the pleasure craft/boat(FORM 3);
  - (ii) Comprehensive map of the area of intended operation, with such information and co-ordinates as may be required by the Registrar;
  - (iii) Fitness Certificate and Builder's Certification of the pleasure craft / boat issued by the certifying agency as prescribed in these rules, certifying the fitness of the pleasure craft/boat for the intended operation;
  - (iv) Valid insurance for passengers covering death or damages.
- (3) Each application, on its submission, shall be endorsed with a unique identification number.
- (4) The Registrar shall be entitled to call for such other documents / records, as may be deemed fit and proper.
- (5) If the Registrar finds the application in order, it shall be transferred for onward scrutiny to the Surveyor; and shall be subjected to a detailed survey.
- (6) The Applicant shall be required to co-operate with the Surveyor in all respects; and shall comply with written directions requisitions and compliances, as may be issued by the Surveyor from time to time. After compliance is rectified, the Surveyor shall inspect the pleasure craft/boat afresh.
- (7) At any stage of the process of evaluation of the application, it shall be open for the Registrar to reject the application, either on its own after recording reasons or on the recommendation of the Surveyor for the reasons that may be conveyed by the Surveyor in writing.
- (8) On satisfactory completion of the survey, if the Surveyor concludes that the pleasure craft/boat is fit in all respects; and meets with the requisite standards for its intended deployment, the Surveyor shall issue a Declaration of Survey in FORM 4. Thereafter, on the bases of the Declaration of Survey, the Chief Surveyor shall issue the Certificate of Survey in FORM 5.
- (9) The Registrar and the Surveyor shall be entitled to call upon the applicant to add / alter / retrofit such apparatus and infrastructure on the pleasure craft/boat, as may be deemed fit and proper. Failure to comply with the directives of the Registrar and the Surveyor shall lead to automatic rejection of the application.
- (10) Thereafter, the Registrar shall on further verification or compliance, as may be required, issue a pleasure craft-specific/boat specific, non-transferrable Certificate of Registration in FORM 6 to the applicant under these rules. The Registrar shall maintain a book of registration in FORM 7.

## 5. Validity of Registration.-

- (1) The validity of the Certificate of Registration shall be five years; thereafter, the applicant shall make a fresh application for the Certificate of Registration. Each Certificate of Registration shall remain valid subject to the compliance of what is stated in these rules, unless terminated / suspended by the Registrar.
- (2) The Certificate of Registration under these rules shall be subject to termination / suspension. During the validity of the Certificate of Registration, the operator shall, at all times ensure absolute compliance of all requirements associated with the safety, utilization and structural integrity of the pleasure craft/boat.

## 6. Procedure for granting permission for operation.-

- (1) Notwithstanding, the operator having valid Certificate of Registration, Certificate of Survey, equipment, the pleasure craft / boat shall not be operated without the valid permission for operation by the District Magistrate having respective jurisdiction.

- (2) The operator seeking permission shall be a registered firm, company or individual or group of individuals governed under the provisions of the Companies Act, 2013, the Income Tax Act, 1961 and Gujarat Goods and Services Tax Act, 2017.
- (3) The operator seeking permission for the activity shall submit a duly filled application to the respective District Magistrate or, as the case may be, Municipal Commissioner, along with all requisite documents.
- (4) The application shall be accompanied with the following documents:
  - (i) proof of ownership of pleasure craft/boat;
  - (ii) valid Certificate of Registration of pleasure craft/boat;
  - (iii) valid Certificate of Survey of pleasure craft/boat and equipment;
  - (iv) comprehensive map of the area of intended operation, with such information and coordinates as may be required by the District Magistrate or, as the case may be, Municipal Commissioner;
  - (v) all required No Objection Certificates from concerned authorities;
  - (vi) valid insurance for passengers (of total sanctioned capacity) covering death or damages.
  - (vii) qualification, certificates of crew member, and
  - (viii) any other document mandated by the District Magistrate or, as the case may be, Municipal Commissioner;
- (5) Subject to successful compliance of documents and verification of antecedents of the operator, the District Magistrate or, as the case may be, Municipal Commissioner may issue permission for water sports activity with the terms and conditions mentioned in the Standard Operating Procedure applicable for the activity in question.

7. Roles and responsibilities of the Operator. -

- (1) The operator shall engage qualified, diligent, and trained crew members possessing a certificate from the National Institute of Water Sports, Port Authority, Gujarat Maritime Board or any other recognised organisation by the Government to the effect that the crew have been trained in-
  - (i) manning and operating the pleasure craft/boat/ equipment;
  - (ii) maintaining, in good operational condition, the pleasure craft/boat / equipment and all life-saving equipment; and
  - (iii) life-saving, first aid and emergency response techniques.
- (2) The operator shall not alter the structure, machinery and equipment without permission of registering authority.
- (3) The operator shall display capacity of the pleasure craft/boat as certified by the Surveyor at the point of embarkation and disembarkation, as also on the pleasure craft/boat itself.
- (4) The operator shall clearly specify area of operation at the time of applying for registration of pleasure craft/boat / equipment with the Port Authority / Gujarat Maritime Board and the same shall be strictly followed for water sports activity. The Zones earmarked for bathing, common public utility, dangerous water bodies or zones within water bodies which are not fit for recreational or water sports activities, shall not be utilized for any recreational or water sport activity.
- (5) The operator shall operate pleasure craft / boat only in the designated/earmarked area only and within visual range so as to be clearly visible from shore at all times.
- (6) The operator shall make available all requisite documents, including but not limited to the Certificate of Registration at all times and shall show it, on demand to the committee officials or to any authority appointed by the Government for this purpose.
- (7) The operator shall implement and maintain adequate fire safety measures to prevent and mitigate the risk of fires.

- (8) Unless otherwise specifically approved, the operator shall ply pleasure craft / boat only during day light and in fair season; and in safe conditions, taking into consideration the applicable dynamic factors, including but not limited to wind speed, unseasonal rainfall or swell in the water body or foggy condition. An operator desirous of conducting night time operation or operations in the fading light, shall be required to seek the necessary permissions with additional lighting and all approvals for the said purpose. It shall be the duty and obligation of the operator to ensure that no pleasure craft / boat is plying in unsafe weather conditions.
- (9) The operator shall observe all safety norms specified by the licensing/Certifying authority.
- (10) Subject to safe operation conditions as stipulated in these rules, the operator shall observe the period and hours of operation as specified in the permission/licence granted by the concerned authorities.
- (11) Where, as part of a recreational activity or picnic (called by any name whatsoever), a school or any educational institution is desirous of providing boating or experience of water sports to its students, the operator may only allow children under the age of 12 years to embark on a pleasure craft if a specific, one-time permission for the said purpose is issued by the District Magistrate or, as the case may be, the Municipal Commissioner under these rules, on the specific request for the said purpose with such undertakings, in the form and manner, as may be called for. At all times when a child or children is/are undertaking boating or recreational water sports activity, such exercise shall always be under supervision of qualified boating operators, lifeguards and such number of adults embarking on a boating journey with the child/children, as may be deemed fit and proper by the operator. Additionally, life jackets for children must be provided and worn at all times during the activity.
- (12) The entire staff of the operator who are directly involved with the operations of pleasure craft/boat must have LST certification from National Institute of Water sports (NIWS) or competent government institution as designated by the Government from time to time. It is expected that personnel indirectly connected with the operations like waiters, receptionists, sweepers etc. also qualify in the First Aid and CPR modules of the LST course so that they can render help in an emergency.

8. Standard Operating Procedure.-

- (1) Each approved activity sanctioned under these rules shall be subject to strict compliance of the Standard Operating Procedure mentioned in Schedule A and such other directives/instructions as may be issued from time to time.
- (2) The operator may, if deemed appropriate apply the Standard Operating Procedure with stricter prescriptions subject to such stricter prescriptions being approved by the District Magistrate or, as the case may be, the Municipal Commissioner. Similarly, considering local circumstances and situations the District Magistrate/ Municipal Commissioner/Local Authority may also stipulate stricter prescriptions for a given activity. In no circumstances the District Magistrate/ Municipal Commissioner /Local Authority /operator be entitled to tone down or make lenient the prescription of the Standard Operating Procedure.

9. Inspection and Monitoring.-

The District Magistrate or, as the case may be, Municipal Commissioner shall constitute a district/city waterside safety committee comprising of such officers as may be appointed by the District Magistrate or, as the case maybe, Municipal Commissioner. The DWSC/CWSC shall conduct annual inspections to ensure compliance of sanctioned activities with these Rules. The DWSC/CWSC may issue such directions and guidelines as may be deemed fit and proper.

10. Penalty:

Any contravention of the rules shall entail the imposition of penalties as per the provisions of the Act.

11. Appeal against penalties under the rules.-

- (1) The State Government may by notification, designate an appellate authority under these rules which shall hear appeals by all aggrieved persons in connection with any decision and order issued under these rules.
- (2) Any appeal under these rules shall be filed within a period not exceeding thirty days from the date of receipt of the decision that is challenged by the appellate. The Appellate Authority may condone any delay in filing of an appeal in an unavoidable circumstance.

- (3) The Appellate Authority shall endeavour to decide an appeal within a period of 180 days from the date of filing the appeal.

Each appeal shall only be registered if it is accompanied with the fee as may be determined by the State Government.

**SCHEDULE A**  
**STANDARD OPERATING PROCEDURE**

(See rule 8)

1. Purpose.-

This Standard Operating Procedure (SOP) establishes a comprehensive framework for the safe operation of category 'C' vessels which are less than 10 meters in length, across Inland Waters as defined in clause (r) of section 3 of the Inland Vessels Act, 2021 within Gujarat; and shall supersede the Interim Guidelines notified by the Government of Gujarat on the 6<sup>th</sup> April, 2024.

2. Scope.-

This SOP shall,-

- (a) apply to all pleasure crafts/boats in Category 'C' vessels, including but not limited to paddle boats, canoes, kayaks, personal watercraft, motorboats, sailboats, and other recreational vessels;
- (b) cover all inland waters within the State of Gujarat;

**District/City Waterside Safety Committee**

3. Purpose and Scope of DWSC/CWSC.-

The District/City Waterside Safety Committee (DWSC/CWSC) shall be established under the Chairmanship of the concerned District Magistrate (DM) or, as the case may be, Municipal Commissioner. The DWSC's/CWSC's primary purpose is to,-

- (a) promote safe operation of water sports and recreational activities;
- (b) prevent accidents and minimize risks associated with water sports and recreational activities;
- (c) enforce established regulations governing water sports' operations and recreational activities within the district/city;
- (d) monitor functioning of Local Government Body/ Municipal Corporation / contractee of PPP agreement.

4. Composition.-

The DM/MC shall establish a District/City Waterside Safety Committee with the following composition:

1	The District Magistrate (DM) or an officer appointed by the DM or, wherever applicable, The Municipal Commissioner (MC),	Chairperson
2	The Superintendent of Police of the District; or an equivalent officer of the Police Administration of a given area. Wherever applicable, an officer appointed by the commissioner of police not below the rank of Superintendent of Police.	Member
3	The Deputy Municipal Commissioner or, wherever applicable, the Resident Additional Collector	Member Secretary
4	Wherever applicable, a representative of the concerned authority / special purpose vehicle which is permitting water sports or recreational activities. (For e.g. Tourism, Medical or any department as deemed by Chairperson.	Member
5	A representative of the jurisdictional Fire Department.	Member
6	Any Expert/ Representative of Association as deemed fit by the Chairperson	Invitee Member

5. Meetings and Quorum.-

- (a) The DWSC/CWSC shall meet at least once in every three months.
- (b) The meetings of the DWSC/CWSC shall be presided by the Chairperson; or, in his absence, any other member of DWSC/CWSC, as may be nominated by the Chairperson for the said purpose.

## 6. Roles and responsibilities of DWSC/CWSC.-

- (a) Regular Inspection and Monitoring: Regular Inspection & Monitoring of all the water sports activities in district/city ensuring compliance with certifications, permissions, and safety standards by appointing government officers from Municipal Corporation/ Concerned Authority/ Contractee of PPP Agreements.
- (b) In-principal sanction to all new agreements executed by the local authorities with private entities for carrying out water sports and recreational activities: Every agreement for operation of recreational and water sports activities shall be placed before the DWSC /CWSC for its In-Principal sanction; and the DWSC/CWSC may, subject to changes, suggestions and modifications, grant or refuse to grant In-principal sanction to such agreement with its suggestions. At this stage, the DWSC/CWSC shall, amongst other things, specifically consider the day-to-day safeguards in place, in the agreement, for the operation of the water sports or recreational activity; and the onus of periodic supervision (in the form and manner as may be prescribed by way of a checklist) by the local authority throughout the tenure of the agreement.
- (c) Establish a Complaint Mechanism: The DWSC/CWSC shall establish a clear and accessible mechanism for receiving and addressing complaints related to safety violations.
- (d) Bathymetric Survey: Inland waters, where water sport activities are being conducted shall be subjected to a bathymetric survey once every three years. The DWSC/CWSC shall, at the cost of the local authority or the operator of the activity (as may have been specified in the agreement between the local authority and the operator), commission the said bathymetric survey through the Gujarat Maritime Board, and in the event of unavailability of the infrastructure of the Gujarat Maritime Board at a given time, through agencies as may be advised by the Gujarat Maritime Board.
- (e) Develop Training Programs: In collaboration with the local body & relevant stakeholders, the DWSC/CWSC shall develop training programs for water sports operators on safety regulations, emergency procedures, and first-aid.
- (f) Creation and Implementation of Waterside safety emergency plan: The DWSC/CWSC shall create an emergency response plan for emergency.

## 7. Reporting.-

- (a) The DWSC/CWSC shall maintain a secure database to record all inspection activities, data collected, enforcement actions taken, and incidents reported related to water sports activities.
- (b) The DWSC/CWSC shall submit annual reports to the Home Department, Government of Gujarat, summarizing inspection findings, trends, and recommendations.

## 8. Review and Improvement.-

- (a) The DWSC/CWSC shall conduct an annual review of the safety aspects of all water sports and recreational activities. This review shall involve,-
  - (i) analysing data on inspections, enforcement actions, and reported incidents;
  - (ii) soliciting feedback from stakeholders, including water sports operators, the public, and relevant government departments;
  - (iii) considering emerging safety concerns and best practices in water sports safety management.
- (b) Based on the review findings, the DWSC/CWSC shall recommend improvements to the waterside safety plan, regulations and training programs.

## 9. Roles and responsibilities.-

- (a) The Government Officers of Municipal Corporation/Local Government Body/ Concerned Authority shall be appointed by the DWSC/CWSC to carry out inspections and fortnightly supervision to verify strict implementation of this SOP.
- (b) In Municipal Corporation's area which has traffic surveillance cameras, shall install cameras on boat jetties to monitor whether passengers wear life jackets and adhere to seating limits, especially during festivals and holidays.

- (c) Conduct surprise checks by local Municipality/Municipal Corporation vigilance teams every month to ensure passengers wear life jackets. Promote life safety awareness through local NGOs. Practice emergency procedures with local fire and emergency services and publicize these activities via media and social media.
- (d) The appointed Government officers shall conduct inspections with due diligence and respect for the rights of operators, ensuring that they identify themselves and present proper identification prior to the inspection, and may take photographs or video recordings as evidence during the inspection.
- (e) Ensure compliance with boat operating contract terms and conditions. The head of local Government body shall review the responsible officer's work during weekly staff meetings.
- (f) The local Government body shall conduct meeting every month with inter- departmental bodies such as the Tourism, Police, and Fire Departments, Coast Guard, Medical Services Department, and other relevant entities, aiming to enforce safety measures in the water bodies.
- (g) In collaboration with relevant stakeholders, the Municipal Corporation/Local Government Body/ Concerned Authority shall develop training programs for water sports operators on safety regulations, emergency procedures, and first aid.
- (h) The Municipal Corporation/Local Government Body/ Concerned Authority shall create an emergency response plan for emergency.

#### 10. Enforcement Actions

Appointed Government Officers have the authority to take the following enforcement actions, depending on the severity of the violation:

- (a) Issue written warnings for minor violations.
- (b) Impose fines for serious violations within the framework established by the rules and any regulations made thereunder.
- (c) Detain non-compliant pleasure crafts until safety deficiencies are addressed. Recommend license suspensions or revocations for water sports operators who repeatedly violate safety regulations, as per the penalty provisions of the rules.

#### 11. Selection process for Boat Operating Agencies.-

The Boat Operating Agencies shall be selected on the bases of an established set of criteria, which shall include, but shall not be limited to,-

- (a) assessment of past experience in managing boat or amusement facilities;
- (b) evaluation of technical expertise pertinent to managing boat operations;
- (c) verification of relevant qualifications and certifications;
- (d) commitment to employ, on a permanent basis, lifeguards, technically qualified boat operators; supervision and managerial personnel; and such other officers as the local authority may require the operator to deploy.

### **Safety**

#### 12. Roles of operators.-

- (a) Passenger Safety Briefings:
  - (i) Before each trip, boat operators shall conduct safety briefings in the local / regional language as also in Hindi. Additionally, the safety briefings shall also be required to be made in any such additional language(s) as may be required depending on the passengers plying the boat.
  - (ii) These briefings shall encompass key safety procedures, the usage and location of safety equipment, especially life jackets, passenger capacity of the boat, boat speed limits, navigation rules, prohibition of smoking on board, and necessary actions in case of emergencies.

- (b) Life Jacket Enforcement:
- (i) Life jackets complying with prescribed safety standards shall be worn by all persons on board during operation.
  - (ii) Life jackets shall be appropriately sized and fastened to ensure effectiveness in emergencies.
  - (iii) For children, life jackets designed for their age and weight shall be used.
  - (iv) Lifebuoys with a throwing line readily available are recommended in every craft as per the seating capacity.
- (c) Compliance with Operational Restrictions:
- (i) Boat operations shall be restricted during unfavourable weather conditions, including but not limited to high winds, thunderstorms, heavy rain, and poor visibility. The operator shall, at all times, ensure that the boat operations are only carried out during safe operating windows.
  - (ii) Boat operations shall be only within permitted zones and timeframes as stipulated by the local governing bodies.
  - (iii) The Boat Operator shall maintain a safe distance from other water users to avoid collision, and operation under the influence of alcohol or drugs is strictly prohibited.
- (d) Safety Equipment: The Boat Operator must ensure that all required safety equipment is onboard and in good condition, including whistle for signalling in distress, a flashlight, and first aid kit.
- (e) Operational Readiness: The Boat Operator should conduct daily inspections of their vessels to ensure that all mechanical and navigational systems are properly functioning.
- (f) Monthly Maintenance: The Boats must undergo mandatory cleaning, maintenance, and service on a monthly basis. Photo and video documentation of these actions shall be maintained by the operator.
- (g) The operator shall engage qualified, diligent, and trained crew members possessing a certificate from the National Institute of Water Sports, Port Authority, Gujarat Maritime Board or any other recognized organization to the effect that the crew have been trained in,-
- (i) manning and operating the boat/ equipment;
  - (ii) maintaining, in good operational condition, the boat / equipment and all life safety equipment; and
  - (iii) swimming, life safety, first aid and emergency response techniques.
- (h) Reporting of unethical practices:
- (i) Any operator working under the jurisdiction of the district/city who observes or has substantial reason to suspect unethical practices, improper conduct, or malpractice involving any appointed government officers/contractors is required and encouraged to report such activities to the DWSC/CWSC. This includes any acts that are considered unethical, illegal, in violation of professional standards, or otherwise inconsistent with the contractual obligations.
  - (ii) The report shall be detailed and include any supporting evidence, to enable the DWSC/CWSC to properly investigate the report. Depending on the nature and severity of the reported unethical practices or impropriety, the DWSC/CWSC may involve other appropriate regulatory or law enforcement bodies.
  - (iii) All reports shall be handled confidentially to the extent that is legally possible. The DWSC/CWSC shall protect whistle-blowers from any forms of retaliation, intimidation, or harassment for making such reports in good faith.

13. Basic Safety Equipment.-

All pleasure crafts must carry the following basic safety equipment:

- (a) Whistle for signalling in case of distress;
- (b) Flashlight for night-time operation (if permitted);

- (c) Anchor (optional for some craft types but recommended for stability and mooring);
- (d) Fire extinguisher (appropriate size and type for the craft);
- (e) First-aid kit (adequately stocked for potential injuries);
- (f) Walkie-talkie or mobile phone.

14. Safety Measures.-

- (a) Permanent signboards shall be erected on the platform next to the boats, which clearly states that it is mandatory for every passenger wishing to travel on the boat to wear a life jacket.
- (b) The number of life jackets for adults and small children shall be at least 20% more than the total boating passenger capacity. Furthermore, old, dirty, or stinky life jackets shall be immediately replaced with new ones.
- (c) Each boat shall visibly display the passenger capacity of the boat.
- (d) Each passenger's name and phone number shall be recorded when issuing a ticket. Records should be kept of how many, and which passengers have gone on each trip.
- (e) Firefighting tools on the boat shall be in place as per the standards and in usable condition; its checking shall be done by the local fire and emergency service once a month.
- (f) On a monthly basis, the boat contractor's employees, who are operating the boat, shall need to undertake a one-day on-site training for safe navigation and maintenance by a retired officer/soldier from the navy. This training is mandatory. It will be necessary to document it with photos.
- (g) Mock drill involving all stakeholders must be carried out once in three months and it should be reviewed by the DWSC/CWSC.

15. Life-guards.-

The Lifeguards shall be trained swimmers and be responsible for,-

- (a) monitoring activities and enforcing safety regulations;
- (b) providing assistance to distressed swimmers;
- (c) administering first aid until further medical help arrives.

16. Emergency Response Boats.-

- (a) Each location where pleasure crafts are operated must have ready access to an emergency response boat, equipped for swift search and rescue operations.
- (b) The required ratio for emergency boats to pleasure crafts is 1:10 for optimal safety and response times.
- (c) In locations where less than 10 pleasure crafts are operated, at least one boat shall be designated and equipped as an emergency boat.
- (d) The Regular training exercises shall be conducted to ensure the proficiency of emergency boat operators in rescue techniques and co-ordination with the District/City Waterside Safety Committee (DWSC/CWSC).
- (e) The fitness and functionality of all emergency boats shall be inspected on a monthly basis to guarantee their operational readiness and compliance with safety standards.

17. Signage and Public Awareness.-

- (a) The Permanent signage shall be erected at boat launching platforms and jetties in Gujarati, Hindi and English. This signage shall prominently display mandatory safety regulations, including,-
  - (i) life jacket use for all passengers;
  - (ii) number of life jackets exceeding total passenger capacity by 20% (including adult and child sizes);
  - (iii) replacement of old, damaged or unsanitary life jackets;
  - (iv) clear indication of the boat's passenger capacity.

## 18. Fire Safety and Crew Training.-

- (a) The following safety measures, as may be required depending on the nature and form of the boating apparatus, must be adopted to prevent fires aboard the boats,-
- (i) regular inspection of electrical wiring, connections, cords, and battery-charging equipment is necessary to ensure they are in good condition;
  - (ii) fire emergency plans must be prepared and regularly exercised;
  - (iii) approved fire extinguishers must be provided and be easily reachable. Training regarding their use should be provided to the boat operator;
  - (iv) fire drills should be carried out every three months.
- (b) In case of a fire aboard the boat, the following steps must be followed,-
- (i) alert passengers and make a distress call using your radio walkie-talkie or mobile phone;
  - (ii) shut off fuel and gas lines immediately;
  - (iii) attempt to extinguish the fire using a bucket or fire extinguisher;
  - (iv) close all hatches, vents, and ports to restrict the flow of oxygen;
  - (v) move any items on fire safely overboard into the water;
  - (vi) if a gas cylinder is in danger of catching fire, the boat must be abandoned.

## 19. Onshore Life Safety Procedures.-

To ensure safe operations on land, the following procedures need to be in place,-

- (a) appropriate communication devices must be installed;
- (b) signage boards featuring safety instructions must be exhibited conspicuously;
- (c) designated areas for embarking and disembarking must be established and clearly marked;
- (d) up-to-date contact information for emergency services must be clearly displayed;
- (e) regular inspections and maintenance of all vessel equipment shall be conducted;
- (f) mandatory installation of CCTV cameras with voice recorders on the jetties/berth is required. These shall be positioned to clearly capture the embarking and disembarking of passengers, passenger briefings and required donning of life jackets before embarking.

## 20. Environmental Safety Standards on Boats and Jetties/Berth.-

- (a) The Boat Operator shall collect all solid waste generated on the vessel to dispose of at designated places on shore.
- (b) All wastewater shall be collected, stored safely and disposed of responsibly.
- (c) Usage of paper or cloth bags shall be promoted in place of polythene bags.
- (d) A system for separating recyclable waste from non-recyclable garbage shall be arranged.
- (e) Proper measures shall be taken to correctly dispose of non-biodegradable garbage to not harm the local environment.
- (f) Vessels using outboard engines shall obtain a pollution control certificate every six months from a competent authority.
- (g) The Boat must be maintained so that there is no leakage of oil or fuel into the water.
- (h) "Do Not Litter" signs shall be posted in areas visible to every passenger.
