Note:-

1. On the aforesaid non-working days port shall remain closed for all traffic operation except arrival/ departure and necessary movement of vessels.
2. If any of the non-working days notified above does not fall on the day specified above, the Port Authority shall have discretion to change and observe the non-working days on which the same is actually going to be largely observed as such.
3. The aforesaid non-working days are to be considered as non-working day under charter party also.
4. In case of any National or State event or occasion subsequently arising including one to be observed locally, the Port Authority Concerned will be competent to notify and non-working days fully or partly on such event or occasion by simple notice to the effect being posted on the Notice Board.
